WHAT IS THE ANTHONY PROGRAM?

THE STATE EXAM

Exams are administered in Oakland several weekdays each month. To pass, you must answer 70% of the 150 multiple-choice questions correctly within 3¼ hours.

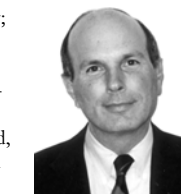

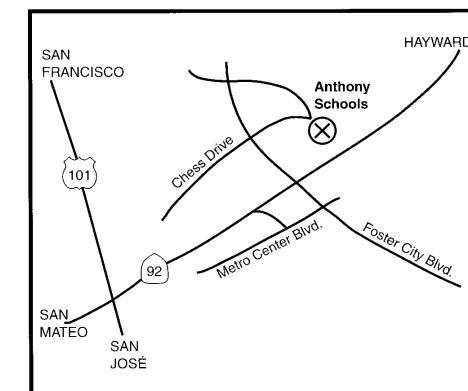

ATTENDANCE AND GRADING

Your tuition includes unlimited class attendance and practice testing for up to six months. If you need more time, three-month extensions currently cost \$125. To receive credit for the course, students must attend all classes, provide photo ID issued by a government agency and score at least 60% on the open-book 100-multiple-choice-question final exam. Independent study courses may not be completed in less than 18 days. We issue transcripts within ten days of course completion.

The California Department of Real Estate has approved these courses for the purpose of obtaining a real estate license and portions are accepted by the California Office of Real Estate Appraisers (OREA Provider No. CP596103) for both basic and continuing education (ask registrar for details).
